THIS CAUSE came on for consideration of bond for an alleged act of domestic violence and the Court being satisfied that it has complete jurisdiction, hereby FINDS that the Court has given particular consideration to the exigencies of the case, including, but not limited to, (a) the potential for further violence; (b) the past history, if any, of violence between the defendant and alleged victim; (c) the level of violence of the instant offense; (d) any threats of further violence; and (e) the existence of any domestic violence protection order prohibiting the defendant from engaging in abusive behavior.

IT IS ORDERED that (a) the defendant shall comply with each bond condition listed below; and (b) a copy of this order shall be provided at no cost to the defendant upon his or her release, to the appropriate law enforcement agency, and to the victim of the alleged crime.

**BOND CONDITIONS**

1. Personally appear on time at all court hearings and other places as directed by the Court.
2. Do not leave the State of Mississippi without permission of the Court.
3. Do not violate any criminal law.
4. Do not use or possess alcohol, illegal drugs, or any prescription drug for which you do not have a prescription.
5. Do not possess or purchase a firearm, ammunition or other dangerous weapon.
6. Do not contact **THE PROTECTED PERSONS**, by electronic communication, telephone or in person, either directly or indirectly through third parties; except as otherwise permitted by this Court or during civil standby with law enforcement present.
7. Do not abuse, harass, stalk, follow or threaten **THE PROTECTED PERSONS** in any manner whatsoever, including the use, attempted use or threatened use of force or physical violence that would reasonably be expected to cause bodily injury.
8. Do not come within 100 yards of:
  - (a) **THE PROTECTED PERSONS**; or
  - (b) **THE PROTECTED PERSONS'** residence, apartment complex or multi-family dwelling; or
  - (c) **THE PROTECTED PERSONS'** place of work or school, except for the following purposes:
